

## Highways Improvements in Denmead

In the next few months Hampshire Highways will be working across the village to make safety and accessibility improvements. As a result of 'developer contributions' otherwise known as 'S106 money' Denmead receives a budget to improve infrastructure. This budget is held for us by Hampshire and the Parish Highways and General Purposes Committee have been working with Councillor Stallard to ensure that the budget is used in the best way possible.

There are five main elements to the project which we hope will be completed before the end of March 2015.

1) **Dropped kerbs and tactile paving** - there are many areas where the kerbs and tactile paving are sub-standard and hinder easy access by visually impaired people, wheelchair users and buggies. These will be replaced to be brought up to current standards

2) **Junior School footway widening and additional parking** - parking around the school has been a significant issue for the nearby residents in Bere Road and Old River, especially during the peak times of the 'school run'. The improvements will provide additional off-carriageway parking using the verge areas along Bere Road

between the Junior and Infants Schools.

3) **Planting on Forest Road roundabouts (by Harvest Home)** - this busy road features two tarmac roundabouts. In order to improve their visual appearance, they will be planted with appropriate vegetation, with the grassed area to the west of the Harvest Home being planted with bulbs. The existing crossing areas will be improved.

4) **Footway at Bunkers Hill to Creech Woods** - the very popular Creech Woods can currently only be accessed by vehicle or by walking on the roadway. Anyone walking this route regularly knows that cars frequently speed along this road making it dangerous for walkers and for parents taking their children to the play facilities in the wood. To ensure pedestrian safety a footway will be installed along the eastern side of Bunkers Hill up to the pedestrian access at the brow of the hill. The existing shallow ditch will be piped to ensure appropriate drainage remains. The current short footway link to Forest Road will be widened.

5) **'Gateway Signs' at entrances to the Village** - to highlight the change in the speed limit when entering the Village, where possible 'Gateway signs' will be erected,


welcoming people to the Village, but also reminding them to slow to an appropriate speed. These have been used to good effect in many villages and will also provide a visual enhancement to the village feel.



## Speeding in the village

Speeding is one of the subjects that we receive most complaints about in the Parish Office and at the various meetings we host and participate in.

Whether it's speeding on Hambledon Road, Forest Road, Bunkers Hill or Anmore Road, speeding is not just anti-social, it's quite simply dangerous.

Whilst it is a recognised priority for the police, they simply can't stretch their resources to provide the frequency of presence that people in the Village say they would like to see.

### So, what can we do about it?

Many communities run their own Community Speed Watch schemes. Locally Bishops Waltham run a very successful scheme.

### What is Community Speed Watch?

It's a traffic monitoring and educational scheme which is intended to empower local people to address speeding issues in their community. Schemes have been running successfully in Hampshire since 2008, with the first

scheme starting 7-8 years ago in Essex, Avon and Somerset and the Thames Valley.

### How does it work?

Volunteers take part in an hour long roadside activity whereby they use speed monitoring equipment to measure vehicles' speed. The locations are predetermined and assessed by police for safety considerations.

Vehicles which travel over the enforceable speed limit are recorded by the volunteers. The owner is then contacted and advised that they have been logged. Further incidents involving the same vehicle are put into an escalation process.

The data collected by the volunteers is available to roads policing officers to assist in the direction of their patrols and enforcement activities.

### Volunteers

Speed Watch is a scheme which centres around and depends on community minded and proactive members of the public.

To be a volunteer, you must be aged at least 17 years.

Applicants will need to complete an application form and vetting process (this can take up to six weeks to clear). Volunteers need to dedicate at least two hours a month to the scheme and the police provide specialist training. Volunteers will be covered under Hampshire Constabulary's public liability insurance for roadside working and will attract 'Police volunteer' status for persons who engage in this social and enjoyable activity.

### We need six volunteers.

## Parish Council land dedicated to sport and recreation

Denmead Parish Council has dedicated Harvest Field and Goodman Fields to be used in perpetuity for sport and recreation as part of The Queen Elizabeth II Fields Challenge, in



commemoration of Her Majesty's Diamond Jubilee in 2012. This means that neither area of ground can ever be sold or built on and will always be available for use as open recreational spaces.

To mark the dedication a display pillar with a commemorative plaque will be erected in both fields. The one in Harvest Field has already been completed and appears in the photograph above.

The pillars were designed by a member of the Parish Council and both will be built by Mr John Finlay, a local tradesman.

A letter has been sent with pictures of the first display pillar to Her Majesty The Queen. A reply from The Palace reads: 'Thank you for your letter of 17<sup>th</sup> September to the Private Secretary regarding two pieces of land in Denmead which have been dedicated to sport and recreation as part of The Queen Elizabeth II Fields Challenge, in commemoration of Her Majesty's Diamond Jubilee.'

I have shown your letter and the attached photographs to The Queen who was pleased to receive them. Her Majesty has asked me to send her thanks and good wishes to you and all those at the Parish Council of Denmead.'

September had been our deadline and working with City Council officers we achieved that, with the City Council six-week consultation going live on the 29<sup>th</sup>.

**October 1<sup>st</sup>:** Today was a significant occasion for the West of Waterlooville Advisory Group as it was able to meet on MDA 'territory' for the first time.

The newly opened school has been made open to us for our meetings and on this occasion the Head Teacher Sue Patrick showed us round the school – where some of the children from the Denmead (i.e. Taylor Wimpey estate) attend. ## Denmead Neighbourhood Plan (DNP) Update

This short article is intended to bring parishioners up to date on where we are with the Denmead Neighbourhood Plan (DNP).

At the end of September, we finished the final version of the Neighbourhood Plan, and forwarded it to Winchester City Council (WCC) for them to check that we had followed the legal process required by Neighbourhood Plan legislation. This they have done, and on the 29<sup>th</sup> September they placed the DNP on their website, and publicised how individuals or businesses can make representations about the revised plan.



These representations may be made by those who make statements in favour of the DNP, or those who oppose part or all of the DNP. You can either fill in the on-line comment form, or you can download a Microsoft Word version of the form – this can be returned by email/post. Whilst using the form is encouraged, you may still make a written representation, and post this to: Head of Strategic Planning, Winchester City Council, City Offices, Colebrook Street, Winchester, SO23 9LJ.

WCC must allow six weeks for representations, and on completion of that period (at 5pm on 11<sup>th</sup> November 2014), they will forward the plan, together with all the evidence supporting the plan, and all the representations made during

this last consultation period, to the Independent Examiner who has been nominated jointly by the DNP Steering Group and WCC. This is a Mr Collison who has examined a number of the NPs in the south of England and elsewhere.

Once he has formally received the plan, Mr Collison will visit Denmead on one day, and expects to take two to three weeks to reach a decision, which is whether the plan is coherent, and is in line with the WCC Local Plan Part 1, and the National Planning Policy Framework. He may ask for a hearing to understand better any issues, but does not have to have such a hearing. If he is content, he will inform WCC that the plan can go to referendum.

I do not intend to go over all the old ground, but there are some significant matters that I believe I should bring to your attention again, and these are “Why an NP”, and what happens if we fail at the referendum.

Why an NP – the Localism Legislation gives parishes the power to decide where building should take place, and where it shouldn't. “How many houses” comes from the work of the Strategic Development Staff of WCC, whose work on Housing Requirements was submitted to a Government Inspector, and resulted in a District figure of 12,500, over the twenty years from 2011 to 2031. This was broken down between city, market towns and significant villages - Denmead sits in the last category, and was allocated about 250 dwellings, which, offset by Little Frenchies Field and other builds post 2011, left us with about 130 to find.

We have therefore worked to decide, whilst strictly adhering to the major factors which decide if a development is sustainable, what sites we should propose to develop. You now know that we will allow smaller sites in School

Lane, Green Lane, Tanners Lane, on Forest Road just to the east of Hatchmore, in Old River, and North of Anmore Road, leaving the remaining requirement of 90 dwellings on a site which would be best in sustainability terms, namely Carpenters' Field.

The major point I am making in this article is that it is vital that we, as a Village, get as many voters as we can to support the DNP at a referendum. The Plan must receive more than half those voting for it to be passed. If the referendum fails, we are without a DNP, and this then leads to a presumption of approval on **ALL** sustainable planning applications submitted!

Given that twenty three sites have been put forward, it is therefore highly likely that many developers with an option on a site outside the current village development boundary will submit a planning application, and this could result in hundreds of extra houses in the Village, with no say on when and where or who the houses are for!

You may also wish to note the parlous situation in East Hampshire, where the District Council does not have a Local Plan at present, but they do have a number of planning applications!

Our MP, George Hollingbury, recently said that a presumption in favour of sustainable means, in effect, if there isn't a good reason to reject, councils should approve it!

George and the EHDC are frantically working to try and resolve the problem in East Hampshire – I don't wish to see Denmead caught in a similar situation.

## Village Agents Needed in OUR Community!

There are thirty five Village Agents in rural communities all over Hampshire. Village Agents are local people who offer between four to six hours a week of their time to signpost and help older people to access information, advice, and local services. They provide

a face-to-face contact point for people who are less likely to use the telephone or internet service to access information. They are also trained to provide a basic home fire safety survey on behalf of the Hampshire Fire and Rescue Service.

The Village Agent programme has been running for three years and has been highly successful in helping to reduce social isolation and loneliness in older people by enabling them to access resources that they need, and assisting them to engage with their local communities

## Your vote counts

### Register to Vote

If you live in Great Britain, you should soon be receiving a form from your Electoral Registration Office to update your registration details

### Why register to vote?

Registering to vote gives you a say on important issues that affect you including:

- Roads
- Recycling
- Education
- Climate change... and much MUCH more!

You may think that right now you don't want to vote, but if an issue comes up you may find you want to have your say. If you are on the register you will have the chance to vote.

Registering to vote does not mean you have to, it just means you can if you want to.

### Who can register?

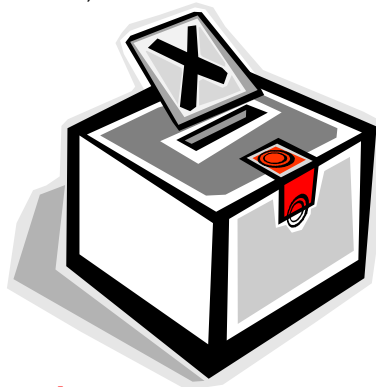
- Anyone 16 or over (you cannot vote until your 18th birthday)
- British or qualifying Commonwealth Citizens. Qualifying Commonwealth Citizens are those who have leave to enter or remain in the UK, or do not require such leave.
- A Citizen of a European Union Country living in the UK, A Citizen of the Channel Islands, the Isle of Man or a British Overseas Territory living in the UK.

### If you are homeless or living in temporary accommodation

Homeless people or people living in temporary or long-term hostel accommodation are entitled to register to vote.

There are two ways of doing this depending on your situation. If you have lived and will be living in relatively stable accommodation for a year or longer it is possible to register in the usual way.

If your situation is less stable: for example if you are sleeping rough or in short-term emergency accommodation, you can register to vote by declaration of local connection. This means that you can register any location where you spend a large proportion of your time. This can be a day centre, a doorway, a project base, shop or café, etc.



### Students

Did you know you may be able to register to vote in local elections at both your home and term-time address?

Providing you live and study in two separate local government areas, students can vote in local elections in both areas. However, you can only vote once in a UK Parliamentary Election.

### What is the electoral register?

The electoral register is a list of everyone who is registered to vote. You need to be on the register before you can vote in an election or referendum. You are not automatically registered, even if you pay council tax.

### How do I register to vote?

You need to fill in an electoral registration form. A form is sent to your house every year, between August and October. Everyone who is eligible to register in your house must respond to the form.

Outside of this period, you can register whenever you want. The electoral register is updated on a monthly basis, but it takes about six weeks to process your registration, so it is important to

register well before the day of an election or referendum.

Registering is easy, simply complete and return a Voter Registration Form which is available to print-off from Winchester City Council's website at: <http://www.winchester.gov.uk/CouncilAndDemocracy/DemocracyAndElections/ElectoralRegister/>

In England and Wales, your local electoral registration office is usually based at your local council. For Denmead, this is the offices of Winchester City Council.

You can get a form from the electoral registration office at your local council, at a library, or a Citizens' Advice Bureau. Fill it in (you can get someone to help you) and return it to the address on the form. This registration will last for up to a year and needs to be renewed every year. You need to provide an address where you can collect mail, or alternatively, you can collect it from the electoral registration office.

### Who can look at the electoral register?

There are two versions of the register – the full version and the edited version. Your details must always appear on the full version, but you can choose whether or not your details appear on the edited register.

- The full register is used for elections, preventing and detecting crime, and checking applications for credit.
- The edited register is for general sale and can be used for commercial activities, such as marketing.
- Anyone can look at the electoral register by going into their local electoral office.
- The electoral register is not linked to council tax.

## HAMPSHIRE COUNTY COUNCIL

### Top for Highways Maintenance

Hampshire County Council has come out top of all County Councils in a national survey of residents' satisfaction with local highway maintenance services. It also took the top spot in satisfaction with street lighting and highway enforcement, second in winter maintenance, and third in satisfaction with the overall condition of the highways.

Hampshire also ranked high, coming fifth out of all county councils for its scores in all highways and transport issues which included highways, tackling congestion, public transport, walking and cycling, and road safety in the National Highways and Transport (NHT) Public Satisfaction Survey 2014.

This is the seventh year of the survey where residents were asked their views on a number of key issues, with seventy eight local authorities in England, Scotland and Wales taking part. Hampshire County Council has taken part in the survey since it started in 2008, one of twenty six authorities to do so.

### Financial Update

Like all other local authorities the County Council has to make significant savings and has consequently drawn up programmes to achieve savings of £102 million by March 2015 and another £100 million by 31st March 2017. New initiatives and service re-design are being explored to maintain levels of service but it is anticipated that Council Tax will remain at zero.

### Concessionary Travel Scheme 2015/2016

Hampshire County Council acquired responsibility for the administration of concessionary travel in April 2011 at an annual cost of £13.5 million. The published scheme is updated annually and on 27th October 2014 the Executive Member for Transport gave approval for the scheme to be published and implemented from April 2015.

On 24 February 2011, the County Council approved the extension from 0930 to 0900 for older persons. However, it has now been approved to discontinue the 0900-0930 Monday to Friday extension to the older person's pass from the start of 2015/2016 scheme as this will deliver an estimated saving of £300,000.

The concessionary travel scheme will still enable -

- **Free** travel at all times for disabled Hampshire Pass holders on journeys commencing in Hampshire to destinations in England
- **Companion** – The Scheme will allow certain Hampshire pass holders who have been issued with a 'Companion pass' to be



accompanied by a companion who is eligible for the same free travel benefits as the pass holder. The companion may be anyone

whom the pass holder considers appropriate to provide assistance

- **Half Fare Travel** on Community Transport Services such as Dial-a-Ride and Call&Go providing that the pass holder meets all relevant eligibility criteria; and
- **Alternative Discretions** - Travel vouchers worth £32 are offered as an alternative concession for those entitled to a disabled person's pass. These are only valid on participating taxis, voluntary car schemes, Dial-a-Ride and Call&Go.

The move from 0900 to 0930 will affect twenty two journeys on infrequent routes across 245 services, both commercial and subsidised, in Hampshire. For those specific journeys where there is currently a departure between 0900 and 0929 and no further journey until 1031 or later, passes would be allowed from 0900 on those specific journeys. No changes are proposed for those eligible for a disabled person's pass which allows travel at all times.

There are now more than 3,000 salt bins in Hampshire to help communities be more resilient through the winter. These are for local people to treat footways and public roads (they are not for use on private drives). These are re-filled regularly, but you can help your community by reporting empty or damaged salt bins at [www.hants.gov.uk/roads](http://www.hants.gov.uk/roads). Remember - a tablespoon of salt (20 grams) is enough to treat one metre square.
