039/15FP **Apologies:** None received.

040/15FP **Declarations of Interest:** There were no declarations of interest made at this time.

041/15FP **Minutes of Previous Meeting:** The minutes of the meeting held on 24th February 2015 were submitted for approval. **It was RESOLVED that the Minutes be accepted as an accurate record and were duly signed by the Chairman of the meeting.**

042/15FP **Public Participation:** Ms Hargreaves and Ms Crawford from the World's End Residents Association volunteered to walk and report on the condition of footpaths in World's End. They stated that Footpath 30 had been re-routed, queried the width of footpaths and added that some discs were missing from signs which they would highlight in their reports. **Noted.**
Matters Arising:

043/15FP (a) **Footpath 26:** A quote had been received to carry out work to the surface of FP 26. A further quote was to be obtained by Cllr West no later than 10th May and will only be considered if cheaper than the quote already received. Grant funding was also to be sought to help with this work. **It was AGREED to request the Finance, Administration and Personnel committee allocate £1,000 from the 2014/2015 underspend towards this project.**

044/15FP (a) **Small Grants Scheme:** The Small Grants Scheme was available for the new financial year with closing dates for applications on 27 July and 26 October. A grant application is to be made for works to FP 26. **Noted.**

045/15FP (b) **World's End Footpaths:** An email had been received from Carolyn Hargreaves offering to survey the footpaths in World's End. This matter was dealt with during the public session.

046/15FP **Healthy Walks:** A healthy walk was being planned for Tuesday 12th May commencing at 7.30 pm from Kidmore Lane car park and heading north of the village. Also a tarmac healthy walk was being organised in the near future for a Saturday. **Noted.**

047/15FP **Condition of Footpaths:** It was reported that footpaths 18, 17, 20 and 5 had been walked on Saturday 11th April and all were in good condition. Footpath 27 had been walked recently and was in a good condition and walkable. Cllr Lander-Brinkley requested that more people walk this footpath as the land it crosses was being advertised for sale. Mr Gibbs agreed to arrange some of his healthy walks to include this footpath.
