- 012/16FP** **Apologies:** Apologies were received from Cllr Andreoli and from Mr Gibbs.
- 013/16FP** **Election of Vice-Chairman for the Footpaths Sub-committee:** It was **RESOLVED** to elect Cllr Hargreaves as Vice-chairman of the Footpaths Sub-committee for the remainder of the municipal year 2015 – 2016.
- 014/16FP** **Declarations of Interest:** There were no declarations of interest made at this time.
- 015/16FP** **Minutes of Previous Meeting:** The minutes of the meeting held on 29th September 2015 were submitted for approval. It was **RESOLVED** that the Minutes be accepted as an accurate record and were duly signed by the Chairman of the meeting.
- 016/16FP** **Public Participation:** Not required.
- 017/16FP** **Matters Arising:**
(a) **Footpath 26:** Work had been completed on sections A & B. There was no funding allocated for section C. Further enquiries are to be made with the land owner of section C. **Noted.**
- 018/16FP** **Draft Walking Strategy Consultation:** The draft strategy was noted and supported.
- 019/16FP** **Correspondence:** There was no separate correspondence to consider.
- 020/16FP** **Healthy Walks:** No new information. **Noted.**
- 021/16FP** **Condition of Footpaths:** All footpaths walked by Cllrs West, Hargreaves, and former Cllr Crooks. Main issues are F/P 33b completely blocked by vegetation, F/P 30 the entrance has been rerouted, F/P 27 where the field has been sectioned a structure is being built does this need planning permission? Most of the finger posts are either hidden in vegetation, missing or damaged. The definitive map needs to be checked for accuracy and we need to arrange for this to be carried out via Hampshire Rights of Way. **Noted.**
- 022/16FP** It was considered that a meeting with an officer from the Rights of Way section at Hampshire would be beneficial to discuss a way forward with Footpaths within the parish.
