The proposal would result in a net loss of retail floor space, and the introduction of further non A1 uses within the Prime Shopping Area of Denmead would adversely affect the vitality, viability and retail attractiveness of the area.

A letter of objection from Mr & Mrs Davies was read out which detailed concerns over:

Lack of pavements.

Lack of access to local services such as schools, health and community services.

Avoid placing an unreasonable burden on local facilities and services.

No public transport.

The site would have no economic role.

The proposed site would be disproportionate in size to the small community of Worlds End and would not be in a geographical situation which would lead to encourage social integration.

Mrs Hargreaves representing the Worlds End Residents Association stated that the 2014 application was refused and the subsequent appeal was dismissed and nothing had changed since then. She urged the parish council to raise a strong objection.

Mr Searle stated that he was concerned from a health and safety perspective in that there were no street lights, no pavements and no buses.
